CONSIGNMENT AGREEMENT

Items accepted for consignment:

We accept new and slightly used clothing, household goods, furniture and other goods that are marketable. Merchandise sold by 2 *Thrifty Pickers* is based on condition, age, suitability, and sell ability in our store or in one of our online options. All clothing must be on hangers, cleaned and pressed ready to sell, no stains, tares, pulls or missing buttons. All other items must be cleaned and in working order. 2 *Thrifty Pickers* reserves the right to refuse any item or merchandise at any time.

Any article of clothing that is found to be stained, tattered or torn and deemed unsellable during the initial tagging process or while on consignment will be discarded (not returned) and noted in the consigner's account as such.

Pricing:

All merchandise will be priced at the discretion of 2 Thrifty Pickers and we reserve the right to discount all merchandise and run sales periodically, as the market conditions dictate. All Clothing items will be marked down by 25% after 30 days and 50% off after 60 days. Other merchandise will be discounted at the discretion of 2 Thrifty Pickers during the consignment period.

Payment:

- Clothing merchandise and accessories will be paid out at 50% of the final sales price it receives to you the consigner.
- Household and furniture merchandise will be paid out at 50% of the final sales price it receives to you the consigner.
- Specialty items, which will be the discretion of 2 *Thrifty Pickers* will be paid out at 75% of the final sales price it receives to you the consigner.
- Internet sale items will be paid out at 50% of the final sale price it receives to you the consigner, less any and all site fees, shipping fees and payment processing fees.
- All payments will be made by check or store credit made out to the consigner printed on this form after the consigned period has ended or all products have been sold on the consigner sales form.

Consignment timelines:

Once an item is taken in by 2 Thrifty Pickers it will be consigned for up to 90 days. During the inventory process you can choose to pick up your items by a specified date or relinquish them to us 2 Thrifty Pickers. Relinquished /abandoned items are donated and or dispersed to various charities or non-profit organizations as deemed fit by 2 Thrifty Pickers. If you have chosen to pick up your items it is your responsibility to visit the store on or prior to the date indicated on the consigner sales form, locate your items and sign off that you have picked them up from our location. It is the consigners responsibility to keep track of their consignment dates for pick up, 2 Thrifty Pickers does not send out reminders and will not be responsible for items not picked up within the consignment timeframes. Failure to pick up your remaining items are considered abandoned and will become the sole property of 2 Thrifty Pickers.

Waiver of Liability:

2 Thrifty Pickers takes reasonable precautions and security measures to protect all merchandise left in our care, however during the consignment period, many customers may touch your items in the course of normal shopping. You agree to release and give up any claims and rights which result from or have to do with the loss, damage or destruction of any and all merchandise. You agree to take any and all risk of loss, damage or destruction for your consigned merchandise by any cause or for any reason.

Agreement:

By signing this agreement you acknowledge that you understand the terms and polices for consignment with 2 *Thrifty Pickers*, LLC and that all of your questions regarding being a consigner with 2 *Thrifty Pickers* have been answered.
